FDA LAW - SYNTHETIC NICOTINE

In May 2022, The Federal Drug Administration, was granted oversight of synthetic nicotine. The FDA now requires manufacturers to submit an approved PMTA in order to market and sell electronic cigarettes containing synthetic nicotine. Product without a PMTA submitted can no longer be sold as of 5/14/2022.

GHRA Warehouse will no longer stock INFUSE and EPIC products in accordance with this deadline. Infuse and Epic products can be returned to the GHRA Warehouse for credit through Tuesday, May 31st. Credit will not be offered on these items beginning Wednesday, June 1st.

In accordance with the FDA ruling, GHRA Warehouse will continue to carry Blu synthetic nicotine products as they await final FDA approval.

For all other brands of synthetic e-cigarette product not purchased from GHRA, please check with your supplier / manufacturer regarding compliance status.

TOBACCO PERMIT EXPIRATION

All tobacco permits on file at GHRA Warehouse will expire on May 31, 2022. Please renew your permits and send GHRA an updated copy .

- ☛ After May 31st, members with expired permits will not be able to receive tobacco products until a valid tobacco permit has been submitted to GHRA Warehouse.
